### **TRAVEL INSURANCE**

We also reserve the right to cancel the retreat, if the event does not attract a minimum of 5 participants. If this occurs, your US\$300 deposit will be refunded.

If we find that the trip is not a good fit for you, we reserve the right to cancel your reservation, in which case your payments will be fully refunded.
